Rights as a member of the Zambia Interactive Homeschool Multi-purpose Co-operative Society Limited

As a member of the Zambia Interactive Homeschool Multi-purpose Co-operative Society Limited I am entitled to:

- Have one vote at general and other co-op meetings and receive proper notice of meetings
- Serve on a committee or run for a position on the board of directors
- Participate in the Zambia Interactive Homeschool Multi-purpose Co-operative Society Limited's operations and governance
- Raise concerns or issues I identify with the Zambia Interactive Homeschool Multi-purpose Co-operative Society Limited
- Receive information about the Zambia Interactive Homeschool Multi-purpose Co-operative Society Limited's financial status and other important processes or decision (e.g. resolutions).
- Receive patronage rebated in accordance with my use of the Zambia Interactive Homeschool Multi-purpose Co-operative Society Limited
- Receive dividends on shares held in the Zambia Interactive Homeschool Multi-purpose Co-operative Society Limited

Responsibilities as a member of the Zambia Interactive Homeschool Multi-purpose Co-operative Society Limited

As a member of the Zambia Interactive Homeschool Multi-purpose Co-operative Society Limited I have a responsibility to:

- Participate in the governance of the Zambia Interactive Homeschool Multi-purpose Co-operative Society Limited through attendance of general meeting, voting on decisions, asking questions, and participating on boards and committees
- Support the mission, vision, and goals of the Zambia Interactive Homeschool Multi-purpose Co-operative Society Limited
- Adhere to the policies and procedures of the Zambia Interactive Homeschool Multi-purpose Co-operative Society Limited set out in the organizational documents and created by the board
- Support the Zambia Interactive Homeschool Multi-purpose Co-operative Society Limited's operations by using its services or contributing to the delivery of services
- Learn more about the Zambia Interactive Homeschool Multi-purpose Co-operative Society Limited's operations and organizational capacity
- Support the capitalization of the Zambia Interactive Homeschool Multi-purpose Co-operative Society Limited by making a financial contribution

Obligations of the Zambia Interactive Homeschool Multi-purpose Co-operative Society Limited to members

As a member of the Zambia Interactive Homeschool Multi-purpose Co-operative Society Limited, I understand that the Zambia Interactive Homeschool Multi-purpose Co-operative Society Limited is obligated to:

- Provide notice of meetings and information on ways that I can participate in the Zambia Interactive Homeschool Multi-purpose Co-operative Society Limited's governance
- Maintain a transparent and efficient system of decision-making that is inclusive of the membership and supportive of the mission and vision of the Zambia Interactive Homeschool Multi-purpose Co-operative Society Limited
- Conduct business, through the board or staff, that is in the best interest of the Zambia Interactive Homeschool Multi-purpose Co-operative Society Limited and its members
- Use my financial contribution effectively and responsibly and redeem my shares in the event I leave the Zambia Interactive Homeschool Multi-purpose Co-operative Society Limited
